Cloud Exemption Request Process

Effective as of May 1st

STEP 1

Requestor submits Cloud Computing Exemption request form.

STEP 2

Cloud Computing Exemption request is reviewed by CDT.

STEP 3

Requestor receives response from CDT.

*CDT review process will take approximately 3-4 weeks

Cloud Migration Strategy Helping the State move to the Cloud

Cybersecurity Maturity Metrics

Increasing program maturity in security awareness

- What it is
 - A measurable way to determine an entity's overall cybersecurity maturity of their respective information security program
- How it Impacts the Community
 - Tying your products/services into the metric to show how you can improve entities maturity and provide value to both parties
 - e.g., Anti-Phishing Training to lower overall click rates to a mature level



Cybersecurity – OIS Procurement Update Increasing program maturity in security awareness

- Technology
 - Managed Security Service Provider (MSSP)
 - Award Pending
- Next Fiscal Year
 - Internal Intrusion Prevention System (IPS)
 - Network re-architecture
 - Anti-Phishing Technologies
 - Identity/Access Management

Cybersecurity – OIS Procurement Update Increasing program maturity in security awareness

 - ➤ GOAL: Streamline procurement vehicles, add capable Vendor partners, and bargain as a State
 - First out of the gate will be advanced endpoint protection and detection
 - Next will be security information and event management (SIEM)
 - Incident Response and Recovery services
